MINUTES OF THE FORTY FIRST ANNUAL GENERAL MEETING
OF THE SILVER FAWN CLUB INC.
HELD ON SATURDAY 25TH FEBRUARY 2012
AT REDHILL COMMUNITY SPORTS CLUB INC.
22 FULCHER ROAD, RED HILL.

The Annual General Meeting of the Silver Fawn Club commenced at 6.45 p.m.

Present: Egerton de Fransz, Chairperson, and 47 Members as per the attendance Register. In the absence of the Secretary, Deanna Misso was appointed pro tem Secretary.

Minutes of the 40th Annual General Meeting held on 12th March 2011 Minutes of the Special General Meeting held on 9th April 2011

Davenal Flanderka proposed that the Minutes be accepted, seconded by Rex Bowen. Confirmed and passed without discussion.

Management Committee Report 2011/2012

The Report had been forwarded to all members. Proposed by Therese Metzeling, seconded by Karol Misso, the Report was received and adopted.

Presentation of Statement of Accounts

He commented on his participation in the Committee and complimented those who had served with him, making special mention of Susan Fahir, Romaine Jayakody, Michael and Therese Metzeling. The House acknowledged its appreciation with applause.

Club Captain:

Norman de la Harpe - proposed by Colin Kellar, seconded by Patrick Maloney.

All were elected unanimously.

Niranjalie Silva thanked all present for their attendance. She said she had a good committee to work with and was looking forward to a productive year. She also had expectations of support from the general membership to make this possible.

At this juncture, Rena Henderling requested permission to read a letter she had received from Isidore Storey. This was met with objections from the Floor on the grounds that no notice had been given, with several members suggesting it be referred to the Management Committee

Appointment of Auditors:

Davenal Flanderka proposed that Mrs. Deepthi Abeywardena be reappointed. This was seconded by Rex Bowen. All in favour.

Appointment of Solicitors:

Gerard Fernando proposed that Sanath Weeratne of Watling Roche Lawyers Australia be reappointed Solicitor. This was seconded by Basheer Omar. All in favour.

Any Other Business:

Referring to the letter from Isidore Storey, Leslie Ephraims stated that reading such a letter would be inappropriate at an Annual General Meeting. This was followed by much discussion from the House. Finally, Sid Shedden suggested the letter be published in the next Newsletter. This was accepted by the House.

Gerard Fernando thanked Egerton de Fransz for all his hard work during his year as President. Egerton graciously acknowledged the applause from the House and congratulated and affirmed Niranjalie in her role as President for the new year.

Therese Prygiel thanked Davenal Flanderka for his commitment, dedication and hard work over many years serving the club and also in his capacity as Vice President during the year ended. This was acknowledged with applause from the House.

Rex Bowen thanked Michael Metzeling for taking on the task of compiling the Newsletter. This too was acknowledged with applause.

There being no other business, at 7.25 pm, Karol Misso proposed that the meeting be closed.

2013/14 AGM Business—Consideration of Change to the Constitution

In accordance with Rule 17 (b) (vi) of the Constitution of the Silver Fawn Club Inc., Mr Pat Sela proposes and is seconded by Mr Maurice de Rozairo, that the existing Rule 26 of the Constitution (Distribution of Surplus Assets) be deleted and the following be inserted as Rule 26.

Rule 26

"If the Club shall be wound up in accordance with the provisions of the "Associations Incorporation Act 1981", and there remains, after satisfaction of all its debts and liabilities, any property whatsoever, the same shall not be paid or distributed among the members of the Club, but shall be given or transferred to the Cancer Council of Queensland."

(This Change to the Constitution has the support of the Management Committee. The Meeting will discuss and vote on the above)

MANAGEMENT COMMITTEE REPORT 2012/2013

Annual General Meeting:

The Annual General Meeting held on 25 February 2012 was attended by 48 members.

Organisation:

All positions on the Management Committee were filled at the AGM held on 25 February 2012. During the year a number of changes were made to the elected Management Committee due to the resignation of Niranjalie Silva (President), Isidore Storey (Vice President), Yvonne Omar (Secretary), Neela Matthews (General Committee) and Ruth Storey (General Committee). Davenal Flanderka (President), Heather Freeborn (Secretary), Leslie Ephraims (General Committee) and Michael Metzeling (General Committee/SilverScene Editor) were elected by the Management Committee to fill some of the vacant positions.

Meetings:

The Management Committee met on 8 occasions.

These meetings were well attended.

Finance:

The financial position of the Club remains strong with most functions showing a surplus. A donation of \$1,000.00 was made to the CCC Foundation, which comprised the generous collection of \$669.80 from attendees at Club functions and a donation of \$330.20 from the Club. Once again this year, the Club received the Brisbane City Council's Senior Citizens Grant which helped partially fund the Golden Years Christmas Party.
