**Any Other Business:**

A change to the Constitution (this change was already circulated in the AGM Papers prior to the meeting) was proposed by Mr Pat Sela and seconded by Mr Maurice de Rozairo that the existing Rule 26 of the Constitution be deleted and the following be inserted as Rule 26.

Rule 26

*"If the Club shall be wound up in accordance with the provisions of the "Associations Incorporation Act 1981", and there remains, after satisfaction of all its debts and liabilities, any property whatsoever, the same shall not be paid or distributed among the members of the Club, but shall be given or transferred to the Cancer Council of Queensland.*

Other suggestions were also made, e.g. the Leukemia Foundation; Children's Cancer Fund etc.,

A vote was taken on this resulting in 34 For and 18 Against.

As the numbers were less than the required percentage for passing this change it was not carried.

Andy Weerasinghe invited members to propose an amendment for the next AGM.

The meeting closed at 8.10pm.

## REPORT OF THE MANAGEMENT COMMITTEE FOR 2013/14

### Annual General Meeting

The Annual General Meeting held on 2<sup>nd</sup> March 2013 was attended by 55 members, with 14 apologies.

### Management Committee

All vacancies for office bearers and the committee were filled at the Annual meeting. However, within the space of four months the committee was confronted with six resignations including that of Treasurer, Asst. Treasurer and Asst. Secretary. The search for replacements was not an easy task with the position of Treasurer being vacant for approximately 3 months. Vice president Egerton acted in this capacity until Shiran Seneviratne was appointed Treasurer from September 2013. The Management Committee met on eleven occasions and worked tirelessly to provide a varied program during the year. However, this was impeded by the inability of some members to contribute fully and as a consequence the task for a few became quite onerous and time consuming.

### Functions/Activities

As mentioned above the committee with little assistance from the general membership was able to offer a varied program of functions and activities.

The Enoggera Bowls Club has proved to be a very convenient and attractive venue for many functions with the Management being extremely cooperative. Not all functions/activities were actively supported by members and the burden of having to gain the interest of sufficient numbers to make functions viable, once again fell on a few committee members.

Functions such as “**Christmas in July**” and the **Golden Years Party** continue to attract traditional numbers, especially from among older members, whereas the popular **Mid Year Anniversary Dance** failed to draw the expected numbers despite the efforts of the committee to make it a special event. Other events such as the **Schools Night** appear to have run their course. **Have-a-Chat** parties, unique to the Silver Fawn Club, maintain their popularity. The programs facilitate fellowship and friendships, old and new, amongst the senior members of the club. **Autumn Reflections** and **In the Mood** were a new experiment with the responsibility of organizing and running the function being undertaken by non-committee members. While this proved successful, it is important that the Management Committee does at all times maintain overall accountability. We returned to the beautiful Riverside Receptions for the **Gala New Years Eve Dance**. Numbers were boosted by family and friends who got their money’s worth with a sumptuous buffet meal, non stop music, and attractive array of prizes. Interest in **Sports’ Days** is flagging, but thanks to the effort of our club captain sufficient support was mustered to put on a Northside/Southside cricket match in conjunction with a successful **Food Fair**. The untiring efforts of the coordinator Claude produced a novel **Christmas Pageant** supported by a small cast of accomplished choristers and organist. The event was much appreciated by members who do value this traditional celebration.

In an attempt to keep the cost of functions within the reach of most members, a variety of caterers was engaged to provide economically priced, yet tasty, no frills meals.

Engaging good professional bands to provide the range of music our members expect has been a challenge. With modern technology and acoustics the occasional alternative of an accomplished Disc Jockey could well be a viable proposition worth considering.

### Finance

The treasurer’s financial statement will reveal that a “status quo” exists in reserved funds. This can be attributed to the diligent management by the committee. We acknowledge receipt of a subsidy of \$245.00 from the Brisbane City Council towards the Golden Years Party. In spite of the low membership cost we believe members **do get good value** for their financial commitment to the club.

## **Re: NOMINATIONS FOR THE ANNUAL GENERAL MEETING**

In recent years I have witnessed an irresponsible 'ad hoc' approach to the election of Office Bearers and Management Committee Members at the AGM. The provision for calling for nominations from the floor under Rule 10.d.d.ii and 10.d.f is there to meet exceptional circumstances. It is neither the norm or an alternative to the process of inviting nominations to be submitted in writing to the Secretary at least 14 days prior to the meeting (Rule 10.d.c.i). The latter together with the requirement that all nominations should have a Proposer and Secunder emphasizes the need for careful thought: that nominees and nominators give due regard to the weightiness of accepting a position of responsibility on the Committee. Calling for nominations from the floor trivializes the process, with individuals being proposed willy-nilly, often ending with someone being coaxed, cajoled to accept office. It is not surprising that the new Committee is within weeks confronted with multiple resignations with others being dragged in to fill the vacancies!

This 'charade' (someone called it a 'circus') must not be allowed to continue: it is a poor reflection on the club. If we want members who are capable and skilled leaders we must elect them in a more responsible way. Those who accept nomination must be committed to contribute to the decision making processes, to plan and execute a range of activities. This does require an ability to work with others who are different; a realization that the democratic process is best served by lively discussion in which all are encouraged to contribute, feel heard and validated; a process where decisions are made on the basis of consensus or majority vote.

If you value the club and believe it has a place in the life of the Sri Lankan community in Brisbane and beyond, do take the process of nomination seriously. You have near on 2 weeks before February 14<sup>th</sup>.
