Greeting members,

It is truly a privilege to lead a wonderful group of members who have volunteered their time to help manage the Club's operations for the coming year. This year's incoming Management Committee comprises a great mix of skills, experience and enthusiasm and I'm confident we will have a successful year, and have lots of fun and good times along the way.

At the AGM, I committed that as a committee, we will focus on three things this coming year:

1. Ensuring we have a fabulous, fabulous 50th Jubilee Anniversary Dance. After waiting so long, we really deserve a great party to mark this significant achievement.
2. Reviewing and updating our Constitution. The current one has served us well but it is long overdue for a refresh and an update.
3. Once we have celebrated our 50th anniversary, we need to start a conversation about what we want the Club to look like in the next 5+ years so we can start planning and working towards it.

So, a special welcome to our new Committee members David Tambyah, Suzie Anthonisz, Sandun Wickramasinghe, Marcelle Moran and Tyrone Allon, who will be joining Susan, Gerard, Fyri, Denis, Thomazine, Ray and myself on the Committee this year. A big thank you also to the outgoing committee members Egerton, Sharyn, Manuka and Davenal for their contribution over the last 12 months. Much appreciated.

We have already had our first meeting of the new Committee and, as you will see in this newsletter, we have a full program of events planned for this year starting with the Annual Camp. Camp Leader Gerard and his band of helpers are working hard on finalising plans and I encourage you to please register early; you'll really be helping us. Our first Have-a-Chat is scheduled for May and you will find information about both these events in this Newsletter.

Covid continues to throw us the proverbial 'curved ball' with our 50th Anniversary Dance plans. Just when we think we have it all covered, issues with the Grand Chancellor as a location for the event continue to cause our members concerns. As a Committee, our problem is that many other possible venues with comparable pricing also happen to be Covid hotels, while the ones which are not (like the Sofitel, Hilton etc) are far too expensive for even a 2-course meal. This said, please be assured that we hear your concerns and at time of writing, we are urgently looking at alternative venue options that could give us something close to the great deal/price that Grand Chancellor is offering, and most importantly, will resolve the on-going venue concerns for our members once and for all.

Before I finish, I want to make one more special thanks to the members who attended the AGM. We took a proposal to the meeting to increase our membership fees and prepared some information which showed what is costs just in fixed costs (eg. Incorporation renewal fees, Insurance, Audit fees, Website costs etc) to run the Club. Members were surprised to hear that fixed costs in 2020 were about \$40 per membership while we only average about \$14 per membership in fees. The members clearly appreciated the authenticity and transparency with which we discussed these financial challenges, and voted us bigger increases than anticipated across all membership categories. More information is in this newsletter. Please note that the new fee increase will be implemented in 2022, not this year.

Overall, I thought the AGM went really well and I felt a great deal of goodwill and support in the room for the incoming Committee. I assure you that we understand the responsibility you have placed in this year's Management Committee. I'm confident the Club is in good hands, and we are committed to being open and transparent in everything we do. It's gonna' be a big year.

SILVER FAWN CLUB INC. ANNUAL GENERAL MEETING

The Fiftieth Annual General Meeting of the Silver Fawn Club Inc., was held on Saturday, 13th March 2021 at 6.00 p.m. at Mitchelton Senior Citizens Centre, 30 Tel-El-Kebir Street, Mitchelton.

41 members attended the Annual General Meeting. The Club received nominations for 11 positions for the 2021 Management Committee.

Club Treasurer, Susan Fahir presented the Financial Report for the year ended 31st January, 2021. The Club recorded an excess of expenses over income of \$6,357. This figure included a shortfall of \$1,992 from functions. The Committee had agreed to subsidise functions for the 50th year and use funds raised from the Food Fair which was held the previous year specifically for this. A copy of the Income & Expense Statement is included in this Newsletter. The previous year functions brought in a surplus of \$6,947.

Egerton de Fransz was appointed a Life Member of the Club.

The meeting voted unanimously to increase membership fees across all categories commencing 2022. The following is a summary of the data presented to the AGM which resulted in the decision to increase fees across the board.

This table compares the income currently received from Memberships with what the Management Committee proposed to the AGM (ie. A blanket \$5 increase across all membership categories) and what members at the AGM approved, which was a \$5 - \$10 increase across the various membership categories.

OBITUARIES



Maurice de Silva, a well respected member of the Sri Lankan community in Brisbane died peacefully on 28th January 2021. He is survived by his adoring wife Moira, loving daughter Tron and grandchildren Zachary and Emily who worshipped him. Maurice was a beloved son in law of Eunice de Silva and brother-in-law of Tania Ponniah and Malcolm and Chrizadelle de Silva. He was a wonderful brother, nephew, cousin, uncle, coach and a friend to many.

Maurice was the third of the de Silva brood of 6 boys and 7 girls from Bambalapitiya. The de Silva family were known for their sporting prowess and Maurice's abilities were first noticed whilst attending St Peter's College. Initially making the history books playing cricket in the 1955 Big Match team who defeated St Joseph's, Maurice also excelled in athletics, hockey and tennis and was awarded the 'Most Scientific Boxer' in the winning Stubbs Shield team. From the foundation of his college achievements, he continued his success playing for Havelocks SC and coaching St Anthony's, Isipathana and the Kandy Lake Club. The pinnacle of his rugby career was representing Sri Lanka and he went on to be widely regarded as one of the greatest centres in the history of Sri Lankan Rugby. Later in life he mastered the game of golf and went on to be an award winning member of the Ashgrove Golf Club for 30 years. He claimed the much coveted Ashgrove Cup in 1997 and joined the 'hole in one club' amongst many other accomplishments.

Maurice moved to Australia in 1973, settling his young family in the leafy suburb of The Gap, which resembled the tree covered hills of Kandy. From the early days he forged strong connections with others Sri Lankans in Brisbane and he soon became a notable supporter of both The Silver Fawn Club and Sri Lanka Society. He was also actively involved with The Sri Lanka Sports Association of Queensland as a founding member and Marist College Ashgrove, GPS Rugby and Valleys Cricket Clubs as a coach. He was well respected by his local community at The Gap and the commitment and passion with which he volunteered at his church, local schools and political events was greatly admired and appreciated by all.

Maurice was a family man who loved his wife, children, grandchildren, parents and siblings and he was always proud of them and their achievements. He lived his life to its fullest and was famous for being the life of every party. He approached everything he did with drive, determination, deep faith and a guarantee of success. These are the traits that are synonymous with the way Maurice lived his life and the qualities that made him an iconic man whose legacy will leave its mark for years to come.

Memories of Dennis Noble

On arriving in Brisbane in February 1972 my mother-in-law suggested that I should join the vibrant social and sports Club – the Silver Fawn Club. I attended the Easter get-together that year and met the Founder members. I knew that Leslie used to referee Rugger matches at my school - St Joseph's College, but all the others were new faces. One of them was Dennis Noble, the Treasurer, a smartly dressed person of English descent.

I remember Dennis always attending Sports functions and the regular Dance Parties and always having time for a chat. He used to inquire about my job and my studies. As an Accountant, I believe he held an important management role in his company, stationed in Papua New Guinea as head of Administration. Through the years I held different positions in the Club and Dennis always congratulated and encouraged me, especially in my studies to be an Accountant. We exchanged many thoughts on accounting and I always enjoyed talking to him. By then the Club had appointed him a Life Member with all the other Founder Members.

I did not know Dennis's family but was lucky to meet his beautiful wife. Eventually I met his charming daughter Gail. I was sorry not to have met his other children, but lucky enough to speak to them on the phone. He had a loving family.

Only a couple of months ago we had a long phone chat, about his illness, my work and my progress in the club. Although he was extremely sick, being the person he was, he spent time finding out how the Club and I were travelling.

When I phoned him about the 50th Anniversary he said he would not be able to attend but would gladly send the Club a congratulatory message. I thanked him for his many years spent in the Club and his efforts with the other Founder Members in forming the Club.

The other day Susan gave me the sad news that Dennis had passed away. Dennis was a noble man, a gentleman to his fingertips and a great person who cared. He was a genuine friend and one who should be admired for his exploits.

CHANGE TO THE CLUB's HONORARY LIFE MEMBERSHIP RULE 3a(iv).

At the recent AGM, members approved the proposed changes to the way we confer Honorary Life Membership to members. Under the new Rule 3a(iv) Honorary Life Membership may be conferred by a recommendation of the Management Committee to the AGM for approval by 75% of members, based on the following conditions:

- ✦ The person being nominated, and the person nominating, must be members for the last 10+ years.
- ✦ Any nominations must be sent to the Secretary by 31 December, with their reasons.
- ✦ Management Committee to consider and recommend or not, based on:
- ✦ Demonstrated (evidence of) commitment to the ideals of the Club
- ✦ Committed service to the Club either on the Committee or in some other significant way
- ✦ All nominations MUST be taken to the AGM, regardless of whether supported by the Management Committee
- ✦ Voting to be by secret ballot

Maximum of 2 nominations per year at each AGM will be approved.

The full wording of the proposed change to Honorary Life Membership Rule 3a(iv) was published in the January/February (pre-AGM) Newsletter.
