I would like to take this opportunity to thank the outgoing committee for their hard work over the last 12 months and the many years before. The efforts of Denis Anthonisz- Secretary, Suzie Anthonisz – Assistant Secretary and Newsletter Editor/Producer, Thomazine Fernando – Assistant Treasurer and Memberships Officer, Ranjan Wijeratne and Namal Wijeratne both General Committee members, were outstanding.

For those of you who couldn't attend the AGM, there was a very strong discussion regarding the lower-than-expected attendees at Club events last year, as well as two events (the Camp and Melbourne Cup) that had to be cancelled due to a lack of support and participation of members. The bad news is that this largely resulted in the club making a loss of about \$2,700 last year. There was also lots of discussion led by Laurensz around the club's financials, which he has summarised in a separate Treasurer's Report later in this Newsletter. I encourage all members to review his report to fully understand the Club's financial position and challenges.

Before I finish talking about the AGM, there's some great news to share with you. I am excited to announce that the outgoing committee has given the club a wonderful parting gift. After three applications over a two-year period, they have recently succeeded in securing a special once-off grant from the QLD Government for \$23,500. No, this is not a typo, just one of the most significant achievements in the club's history. The funds are going to help us refresh all our old archaic club assets such as our computer, music/PA system, audio-visual gear etc which have long been written off. This will effectively set us up for the next 5 – 10 years which is just great. Best of all, we have been given sufficient funds in the grant to finally get our Club website professionally rebuilt.

To summarise, we have a great new committee, some new energy, ideas, and soon we will have all new equipment and a flash new website too, so it all boils down to one thing. Now, more than ever, your participation is paramount to the success of events, and the ongoing success and growth of our Club. We must understand that the Committee is made up of a dozen or so members who have graciously volunteered their time, in the process sacrificing their personal, family, and professional time. This is for a period of 12 months, all with a view to providing you with exciting events. Keeping this in mind, I ask you to please continue to attend as many events as possible and contribute towards its success.



### **Treasurer's Report**

Dear members,

Firstly, I'm obliged to point out that the Audited Financial Report for 2023 was signed by Denis Anthonisz and myself, as former Secretary and President. This was at the request of the Auditor who made the following comment in his Audit report as follows:

The President of the Silver Fawn Club, Mr Laurensz Manricks provided the information required to complete the Audit for 2023/2024. The President advised that no Treasurer was appointed at the AGM on 11th March 2023. He further advised that, subsequent to the AGM, Ms Nichol Pieris expressed an interest in joining the Committee and was elected to the position of Treasurer at the first meeting of that Management Committee on 27th March 2023. Ms Pieris attended only two monthly Management Committee meetings after 27th March due to personal and family circumstances. At Committee meetings since Oct/Nov 2023, Mr Manricks kept the committee updated of his many unsuccessful attempts to contact Ms Pieris to work on the financial reports for the year. Committee agreed that Mr Manricks to assume management of the club's fiscal activities in the interim.

As mentioned by our new President, the club made a Net Deficit of \$2,768 last year, and the Income and Expense Statement on page **10** clearly shows the reasons. We made a decent surplus at the Anniversary Lunch, Bollywood Night and especially the Christmas Party, but had deficits on four other events, the largest being over \$800 at our New Year's Eve Dance. When you count the cancellation of the Camp which usually makes the year's highest surplus, and one other function, it all points to what I candidly mentioned in my last President's Report; our committee never really felt sufficiently supported throughout the year which eventually impacted our bottom line. As you can see, our Total Income from Functions was significantly down (by \$9,000) on the previous year.

Looking at the Expenses side, I want to make one very important point, that has been made many times over the last few years. Total Expenses last year to keep the club running was \$7,521, and \$6,757 the year before. When you divide this by about 100 – 120 family memberships, it means that membership fees should technically be \$65-\$75 per year!! Clearly, this is not possible, which is why it is **absolutely crucial** that members support EVERY event the club puts on and, in droves. Put another way, no committee has any hope of covering \$7,500-odd of fixed costs to run this club without members' support. I can't spell it out any more simply or clearly, dear members.

As outlined in this Newsletter, the new Committee has already taken steps to reduce Newsletter costs. Initiatives like this will help but will not fix the problem.

As Brian said in his report, we have a new committee, with new energy and enthusiasm, and a fantastic influx of money to update our club assets. Now all we need is our members to support everything that is planned for this coming year, and just come have a great time.

Keep well, stay safe and be kind to each other.

### **Changes to the Club's Newsletter**

#### **IMPORTANT MESSAGE**

As you will see from the club's financials (in this Newsletter), it costs the club about \$1,800 - \$2,000 each year to print and post the Newsletter. The Committee has decided to reduce the frequency of this Newsletter to quarterly rather than every two months. This is a major cost-saving initiative which, alone, could save us at least \$600+ this year.

We currently print and post about 80 – 100 Newsletters every two months. If we can get members to receive their Newsletter via email, the potential savings could be more than \$1,000 next year. And with Australia Post announcing more big increases as of April this year, we really need to cut costs in this area.

We currently have members who have been receiving a printed copy as well as an electronic copy of the Newsletter, again adding unnecessary costs for the club.

We encourage all members to please ensure that the Club has a current email address so that we can send you an electronic copy of the Newsletter going forward. Not only will we make important cost savings for the Club, but we also help the environment by not printing so much, and most importantly, you will receive your Newsletter at least a week before any printed version hits your mailbox and it will be in full colour whereas the print edition is mainly in black and white.

The Committee will work on collecting as many email addresses as possible from members. With the reduction in the number of Newsletters to quarterly, it becomes even more important that we have an email address for all members so that we can maintain regular contact with everyone whenever needed, using email blasts.
