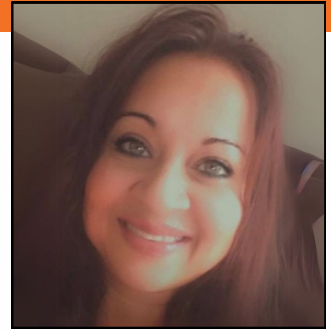
## MESSAGE FROM THE EDITOR

Overall, 2025/26 was a highly successful year, supported by the Management Committee, with continued improvements to Club operations including the website upgrade and CRM implementation.

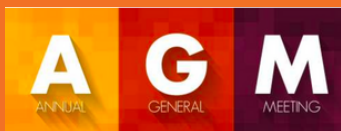

# Minutes of the Annual General Meeting

## President's Welcome

Brian Dissanayake welcomed everyone and opened the meeting at 6:11pm. An apology was made regarding the change of the original date of the AGM due to circumstances beyond our control. He thanked all members for attending the AGM and all our functions and thanked them for their continued support. He expressed his hope that members continue to support us again. He thanked the Committee, who worked tirelessly and were a very enthusiastic group. He thanked this team for their help this year and the former committee members who assisted in many ways. He thanked Past Presidents on the Committee for their support especially Gerard and Laurensz. Brian commented on the pleasing attendance today.

## One Minute's Silence

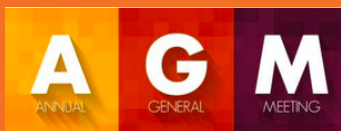
Brian asked for a minute's silence for our members who had passed away in the last twelve months. Evelyn Berenger, wife of our former president Rick Berenger, Aloma, sister of Rowena Western and aunt of Laurensz Manricks and Rev Geoffrey Misso, brother of Karol Misso and Hortence Deuce. Brian apologised for any members he may have missed mentioning but our thoughts were with them and their families.

**Confirmation of the Minutes** of the Annual General Meeting on Saturday 9th March 2024 as proposed by Arlene Dias and seconded by Laurensz Manricks be accepted. These Minutes were published in the January-February Newsletter.

**Management Committee Report** for the year 2024/2025 was compiled and presented by Deborrah Jansz-Cox as published in the January-February 2025 newsletter. Brian briefly went through the information commenting on the following:

- Brian stated that we had 8 functions last year plus the AGM. Only one function, the FSOQ event, was a bit disappointing with participation. From a financial point of view this was the only function that ran at a loss.
- We also brought back the Christmas in July event.
- We introduced a dual event of Hoppers and Egg Hoppers as a Have a Chat function. It was well attended although we had a few shortcomings. Brian contacted all members who attended by email for feedback and out of that a dozen or so responded with positive comments. A round of applause to caterers Brian and Sri was accorded. For those who may have been disappointed he apologised but believed everyone had a good time at the function.
- The camp was our most successful event and was run by Isidore Storey, Andy Weerasinghe, Herbie Tucker, (all Past Presidents) with the subcommittee of Debbie, Niranjalee, Lorraine, Preethi, Ruth who all did a tremendous job managing the tasks.
- All other events were detailed in the newsletter for reference.
- Brian thanked the outgoing Committee for the hard work they had done and their

- support towards each other and to the members throughout the year. It was encouraging to see the way in which the meetings were conducted, and this was a healthy sign for the Club. He thanked the outgoing Committee of Gerard Fernando, Ray Anthonisz, Laurensz Manricks, Deborrah Jansz-Cox, Tyrone Allon, Maithri Jayawardhana Ranjan Wijeratne and Namal Wijeratne. There were three vacancies on this Committee, but 9 people worked throughout the year and he thanked them for the efforts. Brian then thanked the Committee members' partners.
- Brian thanked Tami for her tireless efforts and support with raffles and wrapping gifts, making food and being a tower of strength to him throughout the year.
- Brian acknowledged Past Presidents, Past Committee Members, Life Members and requested they all stand for acknowledgment of all the hard work done to keep the Club operating for many years.

### Treasurer's Report

Laurensz Manricks presented the financial reports referring to the copies which were distributed. He thanked Shiran who has been fantastic and supportive. Shiran's charge of \$500 was very generous and has remained the same for the last 5 years.

He then touched on the points listed below:

1. Income and Expenditure - Surplus 5k of depreciation of \$5000
2. Depreciation of around 5k as we write off assets and this may continue next year
3. FSOQ needs to be supported even though we ran at a loss this year, we need to be present and requested support from the members.

4. He asked if there were any questions regarding Profit and Loss Statement
5. The Balance sheet was briefly discussed
6. Gambling grant of \$23,500 was discussed, there is a balance of \$1168 remaining which may need to be refunded back to the grant providers.

Laurensz asked if anyone had any questions regarding the information. Camp numbers were disputed by Andy Weerasinghe who said the numbers were closer to 100. Laurensz proposed the financial reports be accepted and this was seconded by Maithri Jayawardhana.

Laurensz proposed Shiran be appointed as the auditor for the next year & all in favour.

It was proposed to appoint Hon. Solicitor Paul Pattison for the next year as proposed by Gerard Fernando and seconded by Brian Dissanayake.

### Election of Office Bearers

Brian vacated the chair as the outgoing President and welcomed Denis Anthonisz as Pro-tem Chairman for the selection of the new office bearers. Denis began by saying thank you to the outgoing committee who have done a wonderful job. He stated that if there was only one nominee for each position then that nominee would be duly elected to the position.

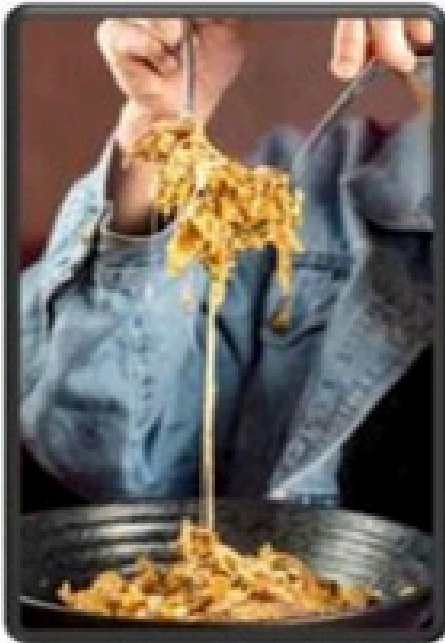

# How to make Kiribath

(Sri Lankan milk rice)

## RECIPE: KIRIBATH

To those of you who are not familiar with the term 'Kiribath', it's a milk rice dish made up of rice and coconut milk. It's an easy breakfast dish you can make with two main ingredients, to usher in the new year or celebrate a memorable occasion.



The rice you use is important as it should be set firmly once the cooked milk rice is poured onto a plate. For this purpose, the rice has to be glutinous and sticky once it's cooked. The best rice for Kiribath (milk rice) is Kekulu. but if you don't have this option then use Jasmine or Basmati.

### INGREDIENTS

- **2 cups of glutinous rice or jasmine rice** (for two adults 1/2, a cup of rice or a little more would do depending on their serving size).
- **2 cups of water** (depending on the type of rice you use, you might need to increase the amount of water by an extra cup of water)
- **1 cup of thick coconut milk**
- **1/2 teaspoon salt** or more to taste
- optional – 2-inch pandan leaf &/or 1-2 cardamom pods gives a subtle taste and aroma to the kiribath)

#### Storing

Any leftovers can be refrigerated in any type of container. consume within 2-3 days.

#### Freezing

Avoid freezing milk rice.

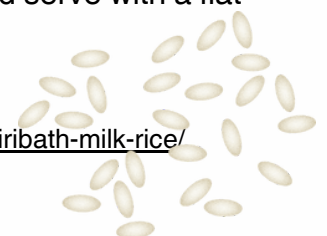
#### Heating

Remove from refrigerator, let it reach room temperature, and consume. You can also warm the milk rice by microwaving it for about 20 seconds.

### INSTRUCTIONS

1. Rinse the rice 2–3 times until the water runs clear, then transfer to a **large saucepan** (the rice will double in volume).
2. Add **2 cups water** (add an extra ½–1 cup if your rice variety needs it). Add a **2-inch pandan leaf** if using.
3. Cook over **medium heat**, watching closely. This rice is intentionally **overcooked** — soft and slightly mushy — but can catch on the bottom, so stay nearby.
4. As the water reduces, **lower the heat**. When the water has almost fully evaporated, the rice should be fully cooked and soft.
5. Add the **coconut milk** and **salt to taste**. Stir, taste, and adjust seasoning if needed.
6. Cook on **low–medium heat** for about **10 minutes**, stirring occasionally, until the rice becomes **creamy and porridge-like**. Keep the heat gentle to prevent sticking.
7. Remove from heat and rest for **2–3 minutes**.
8. Transfer to a **pyrex dish or lined tray**, gently spreading and flattening the rice. Smooth the surface with the back of a spoon.
9. Leave to **cool completely until set**. Kiribath is traditionally served cold.
10. Slice into **squares or diamonds** and serve with a flat spoon.

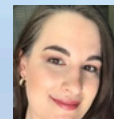


